

## ACC and PCUK advertising media pack 2019

Association of Christian Counsellors (ACC) is an incorporated UK charity, limited by guarantee. It was founded in 1992, after extensive discussion with Christian counselling organisations and individual counsellors, about the growing need for a nationwide organisation to:

- represent and support Christian counsellors throughout the UK
- pursue excellence in all aspects of Christian-based counselling
- develop training in pastoral care in response to growing interest in pastoral counselling both within and beyond Church communities

ACC is the only Christian UK-wide counselling organisation holding an Accredited Register with the Professional Standards Authority. ACC's mission is **to facilitate the provision by Christians of quality counselling and pastoral care**; it defines Christian counselling as those activities which *"...seek to help people towards constructive change and growth in any or every aspect of their lives, through a caring relationship and within agreed relational boundaries, carried out by a counsellor who holds a Christian worldview"*.

Today ACC represents, supports and speaks for around 1,500 members and 100 affiliated organisations. These include counselling students, counselling practitioners, counselling supervisors and pastoral care members. Our affiliated organisations include counselling agencies, training agencies, para church organisations and churches.

Pastoral Care UK (PCUK) was launched as part of ACC in 2013 to focus on supporting individuals, churches and organisations to deliver and understand pastoral care. It offers membership and a range of pastoral care training courses.

Our affiliate members alone deliver some 150,000 client counselling sessions each year, touching the lives of distressed men, women and children of all ages and backgrounds.

### Accord magazine

**Accord** is published quarterly and is slightly under A4 format full colour glossy magazine. It is circulated to all members and affiliated organisations. Current circulation is around 2,500 copies.

Please send your advert in the following formats:

- If you generate your advert in Microsoft Word or Microsoft Publisher, supply a jpg or pdf file.
- If the logo is sent separately from the text, it should be in one of the following formats: jpg, pdf, png, eps, ai or gif
- If your advert is a complete repeat from a previous edition, you need only to supply the page number and name of the edition.

# ACC website advertising policy

## Introduction

- In response to requests from non-members who wish to advertise vacancies, courses and events etc, the Association of Christian Counsellors has decided to take paid advertising from non-members provided it is relevant to the aims and principles of ACC and PCUK. A similar service will be open to ACC and PCUK members, who will receive a discount. Please see the section above about copyright – this is the advertiser's responsibility.
- Payment needs to be made in advance of publication for advertising on the ACC website.

## Pricing to organisations that are not affiliated to ACC / PCUK

One-off adverts, such as for recruitment or to publicise an event cost £105 + VAT to remain on the website until the closing date (or three months, whichever is sooner).

Continuing adverts cost £105 + VAT per quarter year or £311 + VAT for the whole year.

## Pricing to affiliate organisations and non-member individuals

One-off adverts, such as for recruitment or to publicise an event cost £64 + VAT to remain on the website until the closing date (or three months, whichever is sooner).

Continuing adverts cost £64 + VAT per quarter year or £190 + VAT for the whole year.

## Pricing to individual ACC or PCUK members

One-off adverts, such as for recruitment or to publicise an event cost £42 + VAT to remain on the website until the closing date (or three months, whichever is sooner).

Continuing adverts cost £42 + VAT per quarter year or £126 + VAT for the whole year.
